

FISHERIES REGULATIONS

1. FISH POND Fishing in the Bokrijk Provincial Domain is only permitted on the Grote Moffert (pond 26 on the general plan)
Entering and fishing on the pond implies that you are aware of and comply with these regulations.
2. OPENING HOURS From 07:00 to 19:00 (until 21:00 from 1 June to 15 August)
No lines are permitted in the water outside opening hours.
3. PRESENCE Anglers may only be present at their fishing spot a half-hour before the opening time, at the earliest.
Anglers must have left the pond no later than a half-hour after the closing time.
4. FISH SPECIES Carp, grass carp, pike, zander (pike-perch), tench, rudd, roach and eel
5. FISHING RIGHTS Are granted by delivery of fishing permits:
 - HALF A DAY: from 07:00 to 13:00 or 13:00 to 19:00 (21:00)

 - SUBSCRIPTION
Price EUR 25.00 for 1 rod per season.
A maximum of one subscription for 2 fishing rods is issued per angler.
6. FISHING PERMITS
 - (Half-day, full-day and subscriptions) are sold at the pond by the special park rangers.
 - Are strictly personal and may not be handed over to third parties. On busy days, the special park rangers can impose a limit of two fishing rods per day.
 - Each angler is only permitted to fish with four rods simultaneously.
7. Using a live net is prohibited. No fish may be taken away from the fishery.
8. Fishing for pike is permitted from 1 June.
9. Using bait feed and boilies is limited to 1 kg per paying angler per day. Feeding fish outside the fish pond opening hours is prohibited.
10. The distance between two anglers must be at least 3 meters. An angler who temporarily leaves his or her fishing spot must take their fishing line out of the water.
11. Anglers must handle their rods themselves. Use of a landing net is only permitted to remove a caught fish from the water. The fishing lines must be perpendicular to the bank line.
12. Fishing with a lure is prohibited. Using an unhooking mat is obligatory. Use of braided line is prohibited. Anglers should only fish with barbless hooks.
13. Fishing with floating bait is not permitted.
14. Dogs must be kept on a leash in such a way that prevents them from entering the pond.
15. Use of boats and remote-controlled bait boats is prohibited.
16. It is forbidden to leave rubbish or other items at the fish pond and/or to cause damage to the dikes or surrounding vegetation and plantings.
17. It is forbidden to enter the water in any way.
18. The use of vehicles around the fish pond is prohibited. Runners and cyclists are also not permitted around the pond.
19. Failure to comply with the above conditions can result in the withdrawal of fishing permits or access to the pond being refused. In such cases, anglers will not be reimbursed for paid permits.
20. VZW Het Domein Bokrijk has the right to change these regulations at any time.
